230152 [Formal Policy Discussions - February 14, 2023]

Pursuant to Charter, Sections 2.103 and 3.100(7), and Administrative Code, Section 2.11, the Mayor shall discuss eligible topics submitted from the Supervisors. The Mayor may address the Board initially for up to five minutes. Discussion shall not exceed two minutes per question or answer.

The following topic was noticed on the agenda representing District 1:

1. Neighborhood Blight

Mayor London N. Breed addressed the Board of Supervisors regarding various initiatives she recently announced to meet the goals for businesses and workers in the City, including legislation on tax reforms to assist current businesses and recruit new ones, and a ballot measure to fund police overtime.

Mayor Breed then discussed the above referenced topic submitted by the District 1 Supervisor. Supervisor Chan began the discussions by asking the following question: How will rescinding the COVID Emergency Order impact the enforcement of laws concerning encampments, graffiti, garbage dumping, etc.? Mayor Breed responded with the various programs already launched to remove graffiti and other innovative programs being created to shorten the time it takes to address this issue. She encouraged residents to use the 311 system to report blight in their neighborhoods.

President Peskin invoked his privilege to remind the Board that their previous suspension of the Graffiti Abatement Ordinance has been rescinded to allow the City to start addressing graffiti blight once again.

Following public comment this matter was filed. No further action was taken.
