# **Inaugural Meeting**

Present: Directors Dorsey, Mahmood, Sauter, Tolentino, and Wang

The San Francisco Downtown Revitalization and Economic Recovery Financing District (DRFD) met in person in regular session, and provided public comment through teleconferencing on Thursday, September 25, 2025.

Erica Major, San Francisco Downtown Revitalization and Economic Recovery Financing District Board Clerk called the meeting to order at 1:34 p.m.

#### 1. Roll Call & Announcements

### 2. Election of Chair & Vice-Chair by Roll Call Vote

Erica Major, Assistant Clerk (Office of the Clerk of the Board), provided the process for the election of the Chairperson and Vice Chairperson.

Clerk Major opened the floor for nominations for Chairperson. Director Sauter nominated himself and Directors Mahmood, Tolentino, and Wang shared in the nomination. Director Dorsey nominated Director Mahmood for Chairperson. Clerk Major closed the nominations for Chairperson. Clerk Major opened the floor to public comment and took a Roll Call vote on the nomination of the Chairperson.

Director Mahmood nominated himself for the Vice Chairperson position and Directors Dorsey, Sauter, Tolentino, and Wang shared in the nomination. #### 3. Report from the Executive Director

Anne Taupier, Executive Director (Office of Economic and Workforce Development) provided a presentation on the formation of the Downtown Revitalization Board and the Mayor's vision to help bring more residents into downtown area with the conversions of commercial to residential units. Taupier touched on the adoption of a series of fee waivers to make building easier in the downtown area for developers. Taupier handed the floor over to Jacob Bintliff, Project Manager (Office of Economic and Workforce Development).

Chair Sauter recessed at 1:47 p.m. and reconvened at 1:59 p.m.

Bintliff presented a PowerPoint that outlined the Downtown Revitalization Zone along with the revitalization overview, he covered the District formation timeframe and noted that there were 1,300 parcels with eligible commercial buildings.
