211194 [Appropriation - Fiscal Cliff Reserve \$64,150,000 - Mayor's Office of Housing and Community Development - \$64,150,000 for Rent Relief - FY2021-2022]

Sponsors: Preston; Ronen, Peskin, Walton, Chan and Mar

Ordinance appropriating \$64,150,000 from the Fiscal Cliff Reserve to the Mayor's Office of Housing and Community Development for rent relief under the Rent Resolution and Relief Fund and \$64,150,000 for the acquisition, creation and operation of affordable, social housing under the Housing Stability Fund in Fiscal Year (FY) 2021-2022.

Chair Ronen, seconded by Member Walton, moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING A NEW TITLE, by changing the source of funding from the Fiscal Cliff Reserve to Certificates of Participation; by increasing the total appropriation amount from '\$64,150,000' to '\$120,000,000' inclusive of \$60,000,000 for Land acquisition for 100% affordable housing per Administrative Code Sec. 10.100-78 (e), \$20,000,000 for development and construction for non-Low Income Housing Tax Credit (LIHTC) social housing, \$20,000,000 Accessibility, life-safety upgrades, and emergency repairs to non-RAD public housing and/or existing Limited Equity Housing Cooperatives and HUD-funded Housing Cooperatives, \$12,000,000 for construction costs for 100% educator housing, serving educator incomes as defined in 2019 Proposition E, including affordable rental or limited equity cooperative or ownership, and \$10,000,000 for elevator installation or upgrades in nonprofit-owned SRO buildings that serve extremely low income residents; and by making other clarifying and conforming amendments.
