Resolution adopting the City's Ten-Year Capital Expenditure Plan for Fiscal Years (FYs) 2024-2033 pursuant to Administrative Code. Section 3.20.

Heard in Committee. Speakers: Brian Strong, Chief Resilience Officer and Director (Office of Resilience and Capital Planning); Supervisor Aaron Peskin (Board of Supervisors); Lydia Ely (Mayor's Office of Housing and Community Development); Greg Wagner (Department of Public Health); Emily Cohen and Gigi Whitley (Department of Homelessness and Supportive Housing); Douglas Legg (Office of the City Administrator); provided an overview and responded to questions raised throughout the discussion. Speaker; Joyce Gallagos; Susan Green, Elena Engle, Joni Eisen, and Paul Wermer (San Francisco Climate Emergency Coalition) Nancy Haber; Corey Montieth; Charlie Sciammas (Council of Community Housing Organizations); Sara Greenwald (350 San Francisco); Eileen Boken; David Pilpel; Francisco Da Costa; Lawrence Baskett (Invisible San Francisco); spoke on various concerns relating to the hearing matter.

Bond shall be scheduled to appear on the March 2024 ballot, and the Public Health and Shelter G.O. Bond shall be scheduled to appear on the November 2024 ballot; and, be it'.
