### **230265 [Ten-Year Capital Expenditure Plan - FYs 2024-2033]**

#### **Sponsor: Mayor**

Resolution adopting the City's Ten-Year Capital Expenditure Plan for Fiscal Years (FYs) 2024-2033 pursuant to Administrative Code, Section 3.20.

*Heard in Committee. Speakers: Brian Strong, Director and Chief Resilience Officer (Office of Resilience and Capital Planning); Charlie Sheehan (Department of the Environment); Supervisor Aaron Peskin, President (Board of Supervisors); Anna Van Degna (Office of the Controller); Anne Pearson (Office of the City Attorney); provided an overview and responded to questions raised throughout the discussion. Elena Engle; Sarah Greenwald; Roni Diamant-Wilson; Judy Rosenfeld; Joyce Gallagos; Speaker; David Pilpel; Eileen Boken; Susan Green; Francisco Da Costa; Charlie Sciammas (Council of Community Housing Organizations); spoke on various concerns relating to the hearing matter.*

**Member Safai, seconded by Chair Chan, moved that this Resolution be AMENDED, AN AMENDMENT OF THE WHOLE BEARING SAME TITLE, on Page 3, Lines 7-10, by adding 'FURTHER RESOLVED, That this Board amends the Capital Plan to revise the amounts of the General Obligation bonds scheduled for 2024, such that the amount of the Affordable Housing & Shelter G.O. Bond shall be increased to \$340 million, and the amount of the Public Health and Shelter G.O. Bond shall be increased to \$320 million; and, be it'. The motion carried by the following vote:**
