The all-volunteer Board of Directors is responsible for the governance, strategies, programs, operating policies and financial affairs of the organization and its housing affiliates. New Directors are elected by current Directors. All may serve two consecutive three-year terms. The Board's Officers - Chair, Vice-Chair, Secretary and Treasurer - are four current Directors. Officers are elected by the current Directors and serve renewable one-year terms.

The purpose of Public Board Meetings is to (1) transact routine business in public, and (2) provide a Public Comment period of 30 minutes for the public to address the Board on items of interest to the public related to current or future governance, operations or services of Conard House, Inc.

During Public Comment, the only role of the Board is to listen to all comments from the public. The Board may request a third-party Moderator to facilitate Public Comment, guide follow-up dialogues or mediate disputes.

Accordingly, the Board is changing its Public Board Meeting format on April 28, 2022, as follows:

- At the beginning of the meeting a Moderator will review the responsibilities of the Board, the purpose and format of the meeting and any follow-up dialog or mediation, and the ground rules for respectful communication during the meeting.
- Speakers during the public comment section of the meeting will be asked to register before speaking. You may register before April 28 by contacting the helpline (discussed on the previous page), or by registering on April 28 while waiting for the on-line meeting to begin. You will be asked to state the subject you wish to address and whether you are a new or returning speaker. Each speaker's name and subject will be noted in the Minutes.
- The Public Comment period is at the beginning of the meeting and each speaker has up to 2 minutes. The public comment can last up to 30 minutes and closes after each speaker had an opportunity to speak for up to 2 minutes. Speakers will not be allowed to yield their time to other speakers.
- The Moderator will prioritize speakers who have signed up in advance of the meeting, and new speakers over returning speakers.
- Speakers (and other attendees) are encouraged to summarize personal comments in writing in advance via the Board Meeting helpline for attachment to the Minutes. Verbal comments, while summarized during the meeting, will not be recorded or entered verbatim in the Minutes.
- Speakers (and other attendees) may request a private follow-up dialogue or no-cost mediation.
