The African American Arts and Cultural District Community Advisory Committee consist of seven voting members nominated by the Supervisor for District 10 and appointed by the Board of Supervisors. Members of the Advisory Committee shall reside within the boundaries of the African American Arts and Cultural District and have the following additional qualifications.

- Seat 1 shall be held by an owner of a business located in the District.
- Seat 2 shall be held by an employee of a nonprofit organization located in the District.
- Seat 3 shall be held by a person with knowledge or expertise regarding the history or culture of the District.
- Seat 4 shall be held by a youth between ages of 14 to 24, inclusive, at the time of appointment.
- Seats 5, 6, and 7 shall have no additional qualifications.

The Committee shall advise the Board of Supervisors, the Mayor, and the Mayor's Office of Housing and Community Development regarding strategies to support and preserve the unique culture and heritage of the African American Arts and Cultural District, and shall provide input to all City agencies in the preparation of reports required under Section 107A.2 of this Code. The Committee shall also advise the Board of Supervisors, the Mayor, and the Mayor's Office of Housing and Community Development regarding any potential need to re-examine the boundaries of the District.

The Committee members may remain on the Committee until the termination of the Committee.

The Committee shall hold its inaugural meeting not more than 60 days after the Board has appointed at least four members.
