Goodlett Place, San Francisco, California to consider the following **File: 110914 Resolution authorizing an increase in the Assessor-Recorder's base fee for recording and indexing the first page of every instrument, paper or notice from \$4 to \$10 pursuant to California Government Code Section 27361(a).** If the legislation passes, it will increase the Assessor-Recorder recording fee for the first page of every instrument, paper, or notice required or permitted by law to be increased from \$4 to \$10.
