The amount of the fee shall not exceed the reasonable costs incurred by the City related to credit and debit card transactions processing and in no event shall exceed:

- 1. 3.25% for any credit card transaction;
- 2. \$3.95 for any debit card transaction, except for transactions specified in Administrative Code, Section 8.34.2, Subsection 3; or
- 3. 3.25% for any debit card transaction with the San Francisco Public Utilities Commission.
