3	Ordinance authorizing settlement of the lawsuit filed by the City and County of San			
4	Francisco against Michael E. Johnson, et al. for \$100,000; the lawsuit was filed on			
5	August 16, 2018, in San Francisco Superior Court, Case No. CGC-18-568954; entitled
