**210961 [Municipal Elections Code - Reauthorization of Non-United States Citizen Voting in School Board Elections]**

**Sponsors:** Chan; Melgar and Walton

Ordinance amending the Municipal Elections Code to reauthorize Non-United States citizen voting in elections for the Board of Education of the San Francisco Unified School District. ASSIGNED UNDER 30 DAY RULE to Rules Committee.

**210962 [Emergency Ordinance - Extension of Temporary Tenant Protections Due to COVID-19]**

**Sponsors:** Preston; Peskin, Walton, Ronen, Chan, Mandelman and Haney

Emergency ordinance to temporarily extend the COVID-19 based limit on residential evictions, which allows evictions only if based on the non-payment of rent or violence or health and safety issues, and which is currently set to expire on September 30, 2021. **210963 [Administrative Code - Extension Of Temporary Tenant Protections Due To COVID-19]**

Ordinance amending the Administrative Code to extend the COVID-19 based limit on residential evictions, which allows evictions only if based on the non-payment of rent or violence or health and safety issues, from September 30, 2021, through December 31, 2021. Resolution authorizing and approving the Director of Property, on behalf of the Department of Homelessness and Supportive Housing, to negotiate and enter into a sublease agreement for 312,000 square feet of property owned by the California State Lands Commission and leased to the California Department of Parks and Recreation, for the City's use as a Vehicle Triage Center at Candlestick Point State Recreation Area, for an initial term of two years, commencing on or about November 1, 2021, for the base rent of \$312,000 per year to be paid through in-kind, public services with an estimated value of \$2,143,920; authorizing the Director of Property to execute documents, make certain modifications and take certain actions in furtherance of the sublease, as defined herein; adopting findings under the California Environmental Quality Act; and finding the proposed sublease is in conformance with the General Plan, and the eight priorities of Planning Code, Section 101.1.  Resolution 1) approving and authorizing the Director of Property, on behalf of the Department of Homelessness and Supportive Housing (“HSH”), to acquire certain property located at 1321 Mission Street (“Property”) for \$86,500,000 plus an estimated \$173,000 for typical closing costs, for a total anticipated amount of \$86,673,000 (“Acquisition Cost”); 2) approving and authorizing HSH, on behalf of the City, to apply to the California Department of Housing and Community Development (“HCD”) for its 2021 Homekey Grant Program (“Project Homekey”) to purchase the Property; 3) approving and authorizing an Agreement of Purchase and Sale for Real Estate for the acquisition of the Property from Mission Smartspace Senior LLC (“Purchase Agreement”), which includes a liquidated damages clause of up to \$5,000,000 in case of default by the City; 4) authorizing the Director of Property to execute the Purchase Agreement, make certain modifications, and take certain actions in furtherance of this Resolution and the Purchase Agreement, as defined herein; 5) affirming the Planning Department’s determination under the California Environmental Quality Act; and 6) adopting the Planning Department’s findings that the Purchase Agreement, and the transaction contemplated therein, is consistent with the General Plan, and the eight priority policies of Planning Code, Section 101.1. Subject: Letter of Inquiry: Mental Health Care Access for City Employees

---

As we have seen, the COVID19 pandemic has increased the need for mental health services, but has also changed the way they are delivered. We have heard from therapists and patients that increasing telehealth services was seen as a critical expansion for mental health care, but, in reality, it only worsened timely access. Provider networks that were already insufficient became further strained and follow up appointments were often not available for weeks or months following an initial intake.

In order to understand whether our City employees and their families are getting the treatment they need in a timely manner, including wait times for an initial appointment, length of wait time between visits, and access to follow up care, we are asking for the following information about the quality of care provided by the health plan providers for City workers:

- What is the number of City enrollees and their family members with each of our health providers?
- For each of our health plans please provide the Board of Supervisors with the average wait to get a first behavioral health appointment from a patient's first request for treatment.
- Please share data on the average wait time after intake for *follow up appointments* for each health plan.
- Please provide a comparison to show how these two data sets - 1) wait times for initial appointments and 2) wait times for follow up appointments - may differ between providers.
- What tools does the HSS have to affect the quality of patient care including the length of time it takes for City enrollees to receive behavioral healthcare?
- How has the HSS addressed the cultural and linguistic competency of each of our providers, particularly as it relates to behavioral health care?

Bilingual officer staffing data for the last ten years. The breakdown of the data should include:

- For the entire Department over each of the last ten years, the total number of bilingual officers and number by language
- For each Police District over each of the last ten years, the total number of bilingual officers and number by language
- For each Police Academy over the last ten years, the total number of graduating bilingual recruits and number by language
- For the entire Department over each of the last ten years, the total number of non-sworn bilingual certified staff

Supervisor Mar requests that the information be provided no later than Monday, October 18, 2021.
