21 WHEREAS, This motion is a purely commendatory interdepartmental action; and

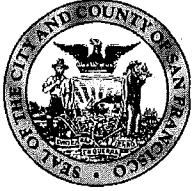
22 WHEREAS, This motion, as provided by the Brown Act, has necessitated immediate


