Pursuant to the Mayor's Third Supplement to the Mayoral Proclamation Declaring the Existence of a Local Emergency, dated February 25, 2020, and supplemented on March 17, 2020, as the Mayor's Designee, I am authorizing the Successor Agency Commission (commonly known as the Commission on Community Investment and Infrastructure or "Commission") to hold its regularly scheduled meeting on Tuesday, April 7, 2020 at 1:00pm.

Pursuant to the Mayor's Third Supplement to the Mayoral Proclamation Declaring the Existence of a Local Emergency, dated February 25th 2020, and supplemented on March 17, 2020, as the Mayor's Designee, I am authorizing the Health Commission to hold an emergency teleconference meeting on Tuesday, March 24th at 3pm. At this meeting, the Health Commission, as Governing Body of Zuckerberg San Francisco General Hospital (ZSFG), will consider approval of the ZSFG Medical Staff Credentialing Report, to enable new medical staff to practice medicine at ZSFG and renew the privileges of current medical staff to continue serving patients.

Hospital licensing regulations require that hospitals have policies and procedures to ensure its medical staff are appropriately credentialed to treat patients. Please note the credentialing process is separate and distinct from the CCSF Human Resource hiring process. The ZSFG Medical Staff Bylaws, which provide the professional and legal structure for medical staff operations, requires that the Health Commission, as the Governing Body of ZSFG, approve, on a monthly basis, a list of new and renewing medical staff applicants.

During this Coronavirus Pandemic, this action is necessary to ensure that ZSFG is fully staffed to treat patients, which ensures the public health and safety of all San Francisco residents.


