The Public Utilities Commission Rate Fairness Board was established to:

- 1) Review the five-year forecast by an independent rate consultant who conducts rate and cost of services studies for each utility;
- 2) Hold one or more public hearings on annual rate recommendations before the Public Utilities Commission adopts rates;
- 3) Provide a report and recommendations to the Public Utilities Commission on the rate proposal; and
- 4) In connection with periodic rate studies, submit rate policy recommendations to the Public Utilities Commission for consideration, including recommendations to reallocate costs among various retail utility customer classifications, subject to any outstanding bond requirements.

The Rate Fairness Board shall consist of seven (7) members:

- City Administrator, or his/her designee
- Controller, or his/her designee
- Director of the Mayor's Office of Public Finance, or his/her designee
- A residential City retail customer, appointed by the Mayor
- A large business City retail customer, appointed by the Mayor
- A residential City retail customer, appointed by the Board of Supervisors
- A small business City retail customer, appointed by the Board of Supervisors

Report: The Rate Fairness Board shall provide a report and recommendations to the Public Utilities Commission on rate proposals.
