



TERMINATION OF ORDERS ISSUED UNDER PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, On February 25, 2020, the Mayor issued a Proclamation of Local Emergency (“Proclamation”) under California Government Code Sections 8550 et seq., San Francisco Charter Section 3.100(14) and Chapter 7 of the San Francisco Administrative, in connection with the imminent spread within the City of a novel (new) coronavirus (“COVID-19”); and

WHEREAS, Certain orders issued under the Proclamation remain necessary to the City’s response to the emergency conditions presented by ongoing COVID-19 pandemic; and

WHEREAS, In light of the current state of the pandemic, the status of the City’s pandemic response, the City’s policies regarding vaccination of City employees and employee return-to-work, the vaccination rates in San Francisco, and the current public health indicators, it is appropriate to terminate several orders issued under the Proclamation as specified below; and

WHEREAS, Section 7 of the First Supplement to the Proclamation required City departments to comply with orders issued by the City Administrator regarding the purchase of commodities and services required to address the emergency; and

WHEREAS, Section 2 of the Third Supplement to the Proclamation authorized the Human Resources Director and the Director of Transportation to temporarily waive provisions of the Civil Service Commission Rules regarding hiring if such waivers were necessary to comply with public health orders or ensure continuity of City operations in response to the emergency; other provisions of Section 2 terminated on November 1, 2021; and

WHEREAS, Section 5(a) of the Seventh Supplement to the Proclamation authorized paid administrative leave for City employees performing essential services who must remain in the workplace when such employees are diagnosed with COVID-19, have symptoms consistent with COVID-19, or must isolate and quarantine as directed by a healthcare provider or public health official; and



WHEREAS, Section 1 of the Thirteenth Supplement to the Proclamation created a modified contracting process for agreements related to the City's response to the emergency of a term of one year or less; and

WHEREAS, Section 1 of the Fourteenth Supplement to the Proclamation required City contractors to provide health insurance to certain employees and dependents where the employee works on a contract with a duration of less than one year that is for food service, delivery service, or cleaning/janitorial service procured for the City's COVID response; and

WHEREAS, Section 2 of the Eighteenth Supplement to the Proclamation authorized the Port Department, Recreation and Park Department, Real Estate Division, and Treasure Island Development Authority to create programs for restaurant and retail to use the outdoor property of these departments, and waived any requirements for commission approval, fees, and any conflicting City laws; and

WHEREAS, Section 2 of the Twenty-Sixth Supplement to the Proclamation authorized the Controller to accept and expend donations of goods or services to support the emergency response, and to specifically authorize acceptance and expenditure of funds, facilities, and goods for purposes of supporting learning hubs and other youth programs; and

WHEREAS, Section 1 of the Thirty-Fifth Supplement to the Proclamation authorized City departments to extend agreements related to the emergency response entered into under Section 1 of the Thirteenth Supplement for an additional year, and revised the reporting requirements for such agreements; and

WHEREAS, Section 2 of the Thirty-Fifth Supplement to the Proclamation revised the modified Civil Service approval process required for emergency-related contracts; and

WHEREAS, Section 3 of the Thirty-Fifth Supplement to the Proclamation authorized the Controller to adopt a policy to allow extensions of existing non-COVID contracts in intervals of up to 6 months but not past June 30, 2022;

NOW, THEREFORE



I, London N. Breed, Mayor of the City and County of San Francisco terminate the following Orders, effective at 11:59 p.m. on July 8th:

- (1) Section 7 of the [First Supplement](#) to the Proclamation, dated March 10, 2020.
- (2) The portion of Section 2 of the [Third Supplement](#) to the Proclamation, dated March 17, 2020, that authorized the Human Resources Director and the Director of Transportation to temporarily waive provisions of the Civil Service Commission Rules regarding hiring if such waivers were necessary to comply with public health orders or ensure continuity of City operations in response to the emergency.
- (3) Section 5(a) of the [Seventh Supplement](#) to the Proclamation, dated March 31, 2020.
- (4) Section 1 of the [Thirteenth Supplement](#) to the Proclamation, dated May 11, 2020.
- (5) Section 1 of the [Fourteenth Supplement](#) to the Proclamation, dated May 13, 2020.
- (6) Section 2 of the [Eighteenth Supplement](#) to the Proclamation, dated June 9, 2020.
- (7) Section 2 of the [Twenty-Sixth Supplement](#) to the Proclamation, dated August 26, 2020.
- (8) Sections 1, 2, and 3 of the [Thirty-Fifth Supplement](#) to the Proclamation, dated February 19, 2021.
