The Board of Supervisors of the City and County of San Francisco met in regular session on Tuesday, January 13, 2026, with President Rafael Mandelman presiding.

President Mandelman called the meeting to order at 2:04 p.m.

ROLL CALL AND PLEDGE OF ALLEGIANCE

On the call of the roll, Supervisors Chan, Chen, Dorsey, Fielder, Mahmood, Mandelman, Melgar, Sauter, Sherrill, Walton, and Wong were noted present.

All members were present.

President Mandelman presented the ancestral homeland acknowledgement of the Ramaytush Ohlone, who are the original inhabitants of the San Francisco Peninsula, pursuant to Board Rule 4.7.1.

President Mandelman led the Members of the Board and the audience in the Pledge of Allegiance to the Flag of the United States of America, pursuant to Board Rule 4.9.

APPROVAL OF MEETING MINUTES

President Mandelman inquired whether a Member of the Board had any corrections to the November 18, 2025, December 2, 2025, and December 9, 2025, Regular Board Meeting Minutes, and the November 17, 2025, Special Meeting Minutes at the Land Use and Transportation Committee Meeting, which constituted a quorum of the Board of Supervisors, as presented. There were no corrections requested from any Member of the Board.

Supervisor Sherrill, seconded by Supervisor Walton, moved to approve the November 18, 2025, December 2, 2025, and December 9, 2025, Regular Board Meeting Minutes, and the November 17, 2025, Special Meeting Minutes at the Land Use and Transportation Committee Meeting, which constituted a quorum of the Board of Supervisors, as presented. President Mandelman informed members of the public that the Special Order at 3:00 p.m. to consider the appeal of the Conditional Use authorization approval for the 825 Sansome Street project (Item Nos. 24-27: File Nos. 251239, 251240, 251241, and 251242) may be continued to the February 3, 2026, Board of Supervisors meeting.

SPECIAL ORDER 2:00 P.M. - Mayor's Appearance Before The Board

260036 [Formal Policy Discussions - January 13, 2026]

Pursuant to Charter, Sections 2.103 and 3.100(7), and Administrative Code, Section 2.11, the Mayor shall discuss eligible topics submitted from the Supervisors. The Mayor may address the Board initially for up to five minutes. Discussion shall not exceed two minutes per question or answer.

The following topic was noticed on the agenda representing District 11:

1. Strategies and funding commitments to address and prevent human trafficking, especially during major large-scale sporting events.

Mayor Daniel Lurie addressed the Board of Supervisors and expressed his appreciation for their continued collaboration. He emphasized his commitment to maintaining a strong partnership and discussed the proposal by Vanderbilt University to establish a full-time academic campus in downtown San Francisco. Mayor Lurie highlighted the broader vision of positioning San Francisco as a global destination to live, work, play, and learn. He noted that the project would bring new energy and talent to the City and underscored its importance as a long-term investment in San Francisco's future.

President Mandelman then invited Supervisor Chen to ask her question related to the noticed topic.

Supervisor Chen began discussions by asking the following question: During major events like Super Bowl 60 and the World Cup, we see a 160% spike in human trafficking cases. What strategies should we implement to address this surge?

Mayor Lurie responded by emphasizing that human trafficking is an ongoing violation affecting people of all ages. He noted that ensuring public safety remains his top priority, referencing the efforts undertaken during Super Bowl 50 to keep everyone safe. Mayor Lurie highlighted a survivor-centered approach that includes partnerships with SFMTA and launching a public awareness campaign to help people identify and report concerns through a "See Something, Say Something" model. He also underscored the importance of year-round training and funding trusted organizations to support concrete, ongoing actions to prevent and respond to human trafficking.

Supervisor Chen followed up by asking the Mayor if we are ready to fund these programs and what strategies are planned.

Mayor Lurie responded by noting a \$902 million increase in funding for gender-based violence programs over recent years, bringing total funding for violence survivors and human trafficking services to \$9.3 billion. He explained that these resources support expanded capacity to address increased incoming calls, legal services, and survivor support before, during, and after major global events, including \$30 million dedicated to long-term housing. Mayor Lurie also emphasized the use of Community-Based Organizations to combat human trafficking and ensure San Francisco remains a safe and welcoming city.

Mayor Lurie did not ask any follow-up questions related to this topic.

Following public comment this matter was filed. No further action was taken.
