The Resolution of Intention was adopted pursuant to the EIFD Law.

The EIFD is intended to provide financial assistance to two development projects: (1) a mixed-use development on an approximately 10.25-acre site in the City, bounded by California Street to the north, Presidio Avenue to the east, Masonic Avenue to the southeast, Euclid Avenue to the south, and Laurel Street and Mayfair Drive to the west, that will include residential, non-residential, open space, child care, and related uses ("3333 California Street Project") and (2) a mixed-use project on a 4.84-acre site in the City, on California Street between Maple Street and Cherry Street, that will include residential, retail, commercial, open space, parking and related uses ("3700 California Street Project").

Infrastructure Financing Plan.
