17 nominee of the District 3 Supervisor, to serve a two-year term ending November 19, 2018, or  
18 for the tenure of the nominating Supervisor, whichever is shorter in duration;

19       Anne Brask, seat 4, succeeding Edward Nicolson, term expired November 19, 2016,  
20 must be a nominee of the District 4 Supervisor, to serve a two-year term ending November  
21 19, 2018, or for the tenure of the nominating Supervisor, whichever is shorter in duration;

22       Melyssa Mendoza, seat 5, succeeding herself, term expired November 19, 2016, must  
23 be a nominee of District 5 Supervisor, to serve a two-year term ending November 19, 2018, or
