18 Roshann Pressman, seat 9, succeeding Oscar Grande, term expired, must be  
19 nominated by the District 9 Supervisor, and shall live, work, own property or own a business in  
20 the "Plan Area" they are appointed to represent, for the unexpired portion of a two-year term  
21 ending October 19, 2017.
