6 **9, and November 6 and 20, 2018; and all Regular Board and Committee meetings during**  
7 **the spring, summer and winter breaks from March 26 through March 30, August 1**  
8 **through September 3, and December 17 through January 4, 2019; and further**  
9 **suspending portions of Board Rule 4.2. to effectuate certain dates within the regular**  
10 **meeting schedule to augment the flow of business.**

12 WHEREAS, The Board of Supervisors Rules of Order, Section 4.2, states the Board  
13 shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at 2:00  
14 p.m., unless it is a holiday, in which case the meeting shall be cancelled; and

15 WHEREAS, The Rules of Order Section 4.2.1 also states that during holiday periods,  
16 the application of specific days of the week described in the rules shall be revised by the Clerk  
17 of the Board as necessary for the efficient conduct of the legislative process; and

18 WHEREAS, The Rules of Order Section 4.2 also states the Board shall not meet during  
19 the week after Thanksgiving, nor between December 24 and December 31; and

20 WHEREAS, Similar to other sitting legislative bodies in the United States, the Board  
21 has established recess periods during the spring, summer and winter which Members of the  
22 Board may plan to be away, without missing any Board or Committee meetings or other  
23 important public business, and without causing difficulties in achieving a quorum; and

1           MOVED, Pursuant to Board Rules 4.2, and 4.2.1 the following Board meetings, are  
2 cancelled: January 2 (New Year's Day); January 16 (Martin Luther King Jr. Day); February 20  
3 (President's Day); May 29 (Memorial Day); July 3 (4<sup>th</sup> of July); October 9 (Indigenous Peoples  
4 Day); November 6 and November 20, 2018; and, be it

5           FURTHER MOVED, That pursuant to the established tradition of spring, summer and  
6 winter recess periods, the Board and Committee meetings scheduled from March 26 through  
7 March 30, and August 1 through September 3, and December 17, 2018 through January 4,  
8 2019 are cancelled; and, be it

9           FURTHER MOVED, To suspend the portion of Board Rule 4.2 which requires the  
10 Board to meet during the week of Thanksgiving; and cancelling the meeting of November 20  
11 to observe the Thanksgiving holiday during the week of Thanksgiving; and, be it

12           FURTHER MOVED, To suspend the portion of Board Rule 4.2 which requires the  
13 Board to cancel a Tuesday Board meeting after a Monday Holiday as it pertains solely to  
14 September 4, to allow the Board to meet on Tuesday, September 4, 2018, and, be it

15           FURTHER MOVED, Pursuant to Board Rule 4.3 the Board is constrained by certain  
16 administrative, electoral and legislative deadlines and may schedule Special Meetings when  
17 necessary to conduct the City's business.
