20 WHEREAS, Ordinance No. 106-17 reserved the funding on Board of Supervisors'
21 reserve pending additional information on the expenditure of funds; and

22 WHEREAS, At the regular meeting of the Budget and Finance Committee on
23 November 1, 2018, the Airport presented information regarding the anticipated expenditure of
24 funds; now, therefore, be it

1 MOVED, That the Board of Supervisors hereby approves the release of the funds
2 described above in the FY 2018-19 budget.
