3 **Motion appointing Jessica Lehman (residency requirement waived), Jennifer Esteen**  
4 **(residency requirement waived), and Sara Short, for indefinite terms, to the Housing**  
5 **Conservatorship Working Group.**

7 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
8 hereby appoint the hereinafter designated person to serve as a member of the Housing  
9 Conservatorship Working Group, pursuant to the provisions of Chapter 5 of the Administrative  
10 Code, Article XXXVII, Sections 537- to 5.37-5, for the term specified:

11 Jessica Lehman (residency requirement waived), seat 2, initial appointment, must be a  
12 representative of a disability rights advocacy group, for an indefinite term;

13 Jennifer Esteen (residency requirement waived), seat 4, initial appointment, must be a  
14 representative of a labor union for an indefinite term;

15 Sara Short, seat 6, initial appointment, must be a representative of an organization  
16 providing direct services to homeless individuals or families for an indefinite term; and, be it

17 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 18 1. The membership of the Housing Conservatorship Working Group has a goal to be  
19 representative of the diversity of the City and County of San Francisco.
- 20 2. Applicants Jessica Lehman and Jennifer Esteen, who are not residents of San  
21 Francisco, are persons with experience that uniquely qualifies them to serve on the  
22 Housing Conservatorship Working Group.
- 23 3. The Housing Conservatorship Working Group has attempted to fill the positions, for  
24 which Jessica Lehman and Jennifer Esteen were nominated, with individuals who are  
25 City residents and who have the specific experience, skills, and qualifications, but has

1           been unable to do so at this time. The Rules Committee has certified that Jessica  
2           Lehman and Jennifer Esteen, are qualified to serve on the Housing Conservatorship  
3           Working Group.

- 4           4. After exercising due diligence, the Board of Supervisors concludes that there are no  
5           other possible representatives, who are residents of San Francisco, and who have the  
6           specific experience, skills, or qualifications possessed by these applicants, and who  
7           are willing to serve on the Housing Conservatorship Working Group at this time; and,  
8           be it

9           FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
10          for Jessica Lehman and Jennifer Esteen, as allowed in cases where no qualified City resident,  
11          willing to serve, can be found, pursuant to Charter, Section 4.101(a)(2), that requires  
12          person(s) appointed to boards, commissions, and advisory bodies established by legislative  
13          act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.


