17 Mervin Conlan, seat 3, succeeding themselves, term expired, must have a minimum of  
18 five years professional experience in the State of California as one of the following: certified  
19 public accountant or public accountant; licensed real estate broker; attorney; or a property  
20 appraiser accredited by a nationally recognized professional organization, certified by the  
21 Office of Real Estate Appraisers, or certified by the State Board of Equalization, for the  
22 unexpired portion of a three-year term ending September 5, 2022.

23 Yosef Tahbazof, seat 4, succeeding themselves, term expired, must have a minimum of  
24 five years professional experience in the State of California as one of the following: certified  
25 public accountant or public accountant; licensed real estate broker; attorney; or a property

1 appraiser accredited by a nationally recognized professional organization, certified by the  
2 Office of Real Estate Appraisers, or certified by the State Board of Equalization, for the  
3 unexpired portion of a three-year term ending September 5, 2022.
