12 hereby approved and said map is adopted as an Official Final Map 9612; and, be it


13       FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own

22       FURTHER MOVED, That approval of this map is also conditioned upon compliance by  
23 the subdivider with all applicable provisions of the San Francisco Subdivision Code and  
24 amendments thereto.


