2 Supplement]

3 **Motion concurring in actions taken by the Mayor in the Twenty-Sixth Supplement to the**  
4 **Proclamation of Emergency to meet the ongoing local emergency related to the novel**  
5 **coronavirus COVID-19 pandemic.**

7 WHEREAS, On February 25, 2020, Mayor London N. Breed declared a local  
8 emergency to exist in connection with the spread of the novel coronavirus COVID-19; and

9 WHEREAS, The Mayor transmitted a copy of that Proclamation Declaring the  
10 Existence of a Local Emergency to the Board of Supervisors (the "Proclamation"), and on  
11 March 3, 2020, the Board of Supervisors concurred in the Proclamation and in the actions  
12 taken by the Mayor to meet the emergency; the Proclamation and the Board's concurring  
13 motion are on file with the Clerk of the Board of Supervisors in File No. 200228; and

14 WHEREAS, On August 26, 2020, the Mayor took additional steps to meet the  
15 emergency by issuing the Twenty-Sixth Supplement to the Proclamation, ordering three  
16 actions to meet the emergency; the Twenty-Sixth Supplement is on file with the Clerk of the  
17 Board of Supervisors in Board File No. 201018;

18 WHEREAS, Government Code, Sections 8550 et seq., and Charter, Section 3.100,  
19 provide for the concurrence by members of the Board of Supervisors in such emergency  
20 declaration and in action taken by the Mayor to meet the emergency; and now, therefore, be it

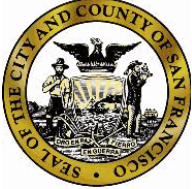
21 MOVED, That the Board of Supervisors concurs with the following actions taken by the  
22 Mayor to meet the local emergency included in the Mayor's Twenty-Sixth Supplement to the  
23 Proclamation, dated August 26, 2020, as that action is described in full in the Twenty-Sixth  
24 Supplement and summarized as follows:

1           Action #1:    Authorizing the Director of Transportation to create a streamlined  
2 process outside the normal ISCOTT process for issuing permits to close streets for outdoor  
3 dining, retail and services. The Director of Transportation must issue rules and regulations to  
4 implement the program.

5           Action #2:    Modifying the April 10, 2020, mayoral order allowing the Controller  
6 to accept and expend donations of goods or services to support the emergency response to  
7 specifically authorize acceptance and expenditure of funds, facilities, and goods for purposes  
8 of supporting learning hubs and other youth programs.

9           Action #3:    Extending the March 17, 2020, mayoral order authorizing the paid  
10 furlough program for City employees through September 30, 2020.
