3 **Motion appointing Jusef Nathan, Joanna Hernandez (residency requirement waived),  
4 Linda Hurshman, and Jabari Jackson, terms ending June 1, 2024, to the Reentry  
5 Council.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
7 hereby appoint the hereinafter designated person(s) to serve as member(s) of the Reentry  
8 Council, pursuant to the provisions of Administrative Code, Sections 5.1-1 through 5.1-6, for  
9 the terms specified:

10 Jusef Nathan, seat 1, succeeding Yolanda Morrissette, term expired, must be a former inmate  
11 in the San Francisco County Jail, a California Department of Corrections and Rehabilitation  
12 facility, and/or a United States Bureau of Prison facility; and also must self-identify as a  
13 survivor of violence or crime, for the unexpired portion of a two-year term ending June 1,  
14 2024;

15 Joanna Hernandez (residency requirement waived), seat 2, succeeding Michael Brown, term  
16 expired, must be a former inmate in the San Francisco County Jail, a California Department of  
17 Corrections and Rehabilitation facility, and/or a United States Bureau of Prison facility; and  
18 also have expertise in providing services to individuals exiting the criminal justice system, for  
19 the unexpired portion of a two-year term ending June 1, 2024;

20 Linda Hurshman, seat 3, succeeding Oscar Salinas, term expired, must be a former inmate in  
21 the San Francisco County Jail, a California Department of Corrections and Rehabilitation  
22 facility, and/or a United States Bureau of Prison facility; and also must have been released  
23 from custody within three years of his/her appointment, for the unexpired portion of a two-year  
24 term ending June 1, 2024;

Jabari Jackson, seat 4, succeeding themselves, term expired, must be a former inmate in the San Francisco County Jail, a California Department of Corrections and Rehabilitation facility, and/or a United States Bureau of Prison facility; and also must have served multiple terms of incarceration, for the unexpired portion of a two-year term ending June 1, 2024; and, be it

FURTHER MOVED, That the Board of Supervisors makes the following findings:

1. The membership of the Reentry Council has a goal to be representative of the diversity of the City and County of San Francisco.
2. Applicant Joanna Hernandez, who is not a resident of San Francisco, is a person with experience that uniquely qualifies them to serve on the Reentry Council.
3. The Reentry Council has attempted to fill the position, for which Joanna Hernandez was nominated, with an individual who is City a resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Joanna Hernandez is qualified to serve on the Reentry Council.
4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representatives who is a resident of San Francisco, who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Reentry Council at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Joanna Hernandez, as is allowed in cases where no qualified City resident who is willing to serve can be found, pursuant to Charter, Section 4.101(a)(2), that otherwise requires

1 person(s) appointed to boards, commissions, and advisory bodies established by legislative  
2 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
