[Amending the Rules of Order - Providing for Remote Public Comment Opportunities]

Motion amending the Board of Supervisors' Rules of Order by creating a new Rule 1.3.3, In-Person and Remote Public Comment, and amending Rule 4.22, Public Comment, to provide for remote comment opportunities by all members of the public who wish to comment remotely.

WHEREAS, Since the onset of the COVID-19 health emergency in March 2020, the Board of Supervisors ("Board") has provided opportunities for members of the public to provide comment remotely, in order to allow for social distancing and reduce health risks; and

WHEREAS, As of March 2023, health conditions no longer impact the ability of most individuals to attend crowded public meetings in person; and

WHEREAS, Notwithstanding the improved health conditions that reduce the risks associated with in-person public comment, the Board finds that remote public comment has allowed for broader participation in the legislative process and has given voice to a diversity of perspectives from across the City; and

WHEREAS, Eliminating remote public comment would likely reduce participation in Board meetings by people who cannot attend such meetings in person for any number of legitimate reasons, such as childcare or eldercare responsibilities, work schedules, lack of resources, or illness; and

WHEREAS, On March 7, 2023, the Board enacted Motion No. M23-039, expressing the Board's intent to amend the Board's Rules of Order to provide for remote comment by all members of the public who wish to comment remotely, and directing the Clerk of the Board to prepare and introduce by no later than March 14, 2023, a motion to amend the Board's Rules

of Order to provide opportunities for remote public comment to all members of the public who wish to comment remotely; now, therefore, be it

MOVED, That the Board amends the Rules of Order of the Board of Supervisors to create a new Rule 1.3.3 and to amend Rule 4.22, to read as follows:

## 1.3.3. In-Person and Remote Public Comment.

Where opportunity for public comment is required under Rules 3.8 (Public Testimony in Committee), 4.19 (Public Hearings on Appeals), and 4.22 (General Public Comment Before the Full Board of Supervisors), members of the public shall be given the option to comment in-person or remotely. For purposes of this Rule 1.3.3., "remotely" means telephonically or otherwise electronically, as determined by the Clerk of the Board of Supervisors.

4.22. Public Comment. This is an opportunity for members of the public to directly address the Board on items of interest to the public that are within the subject matter jurisdiction of the Board, including items being considered at this meeting which have not been referred to committee, and excluding items which have been considered by a Board committee. Members of the public may address the Board for up to three minutes. The President or the Board may limit the total testimony to 30 minutes. At the conclusion of public comment, the Board may not lawfully take action to approve or disapprove a new proposal which is not on the agenda, but may refer the proposal to a City official for review.

During public comment before the full Board, remarks shall be addressed to the Board as a whole, not to individual Supervisors and not to the audience. Supervisors shall not enter into debate or discussion with speakers during public comment. The President may request a City official to investigate an issue raised and later report to a committee or to the Board.
