3 **Motion approving the President of the Board of Supervisors Aaron Peskin’s nomination**  
4 **of Jesssica Campos (residency requirement waived) for reappointment to the Child**  
5 **Care Planning and Advisory Council, term ending March 19, 2027.**

7 WHEREAS, The President of the Board of Supervisors Aaron Peskin has submitted a  
8 letter notifying the Clerk of the Board of Supervisors of the nomination for the reappointment  
9 of Jessica Campos to the Child Care Planning and Advisory Council pursuant to the  
10 provisions of the Administrative Code, Article XX, Section 5.200, and Section 10.100-367, and  
11 California Education Code, Sections 8499.3-8499.7, received by the Clerk of the Board on  
12 May 7, 2024; now, therefore, be it

13 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
14 hereby approve the President of the Board of Supervisors’ nomination for the reappointment  
15 of Jessica Campos (residency requirement waived) to the Child Care Planning and Advisory  
16 Council, seat 12, succeeding themselves, must be a nominee of the President of the Board of  
17 Supervisors and represent one of the following categories: consumers, child care providers,  
18 discretionary, community representatives, or public agency representatives, for the unexpired  
19 portion of a three-year term ending March 19, 2027; and, be it

20 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 21 1. The membership of the Child Care Planning and Advisory Council has a goal to be  
22 representative of the diversity of the City and County of San Francisco.
- 23 2. Applicant Jessica Campos, who is not a resident of San Francisco, is a person with  
24 experience that uniquely qualifies them to serve on the Child Care Planning and  
25 Advisory Council.

1           3. The Child Care Planning and Advisory Council has attempted to fill the position, for  
2           which Jessica Campos was nominated, with an individual who is City a resident and  
3           who has the specific experience, skills, and qualifications, but has been unable to do so  
4           at this time. The Rules Committee has certified that Jessica Campos is qualified to  
5           serve on the Child Care Planning and Advisory Council.

6           4. After exercising due diligence, the Board of Supervisors concludes that there is no  
7           other possible representatives who is a resident of San Francisco, who has the specific  
8           experience, skills, or qualifications possessed by this applicant, and who is willing to  
9           serve on the Child Care Planning and Advisory Council at this time; and, be it

10           FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
11           for Jessica Campos, as is allowed in cases where no qualified City resident who is willing to  
12           serve can be found, pursuant to Charter, Section 4.101(b), that otherwise requires person(s)  
13           appointed to boards, commissions, and advisory bodies established by legislative act of the  
14           Board of Supervisors to be resident(s) of the City and County of San Francisco.
