7 WHEREAS, The Joint Zoo and Recreation and Parks Committee Animal Welfare  
8 Advisors released a “San Francisco Zoo Recommendations” report on October 10, 2024, on  
9 file with the Clerk of the Board of Supervisors in File No. 241027, which is hereby declared to  
10 be a part of this Motion as set forth fully herein; and

11 WHEREAS, The report included a specific recommendation that the Board of  
12 Supervisors request a current performance audit of the San Francisco Zoo; and

13 WHEREAS, The Budget and Legislative Analyst last conducted a performance audit of  
14 the San Francisco Zoo in 1999; and

15 WHEREAS, It is the policy of the Board of Supervisors to conduct audits in accordance  
16 with Charter, Section 2.114, to ensure that City departments make prudent and efficient use of  
17 City resources and that departments effectively perform the functions assigned to them by the  
18 Charter and applicable laws; and

19 WHEREAS, The Commission of Animal Control and Welfare voted unanimously to  
20 support the recommendations in the report; now, therefore, be it

21 **MOVED, That the Budget and Legislative Analyst is hereby directed to initiate a**  
22 **performance and management audit of the San Francisco Zoo as part of their FY 2024-2025**  
23 **and FY 2025-2026 Audit Schedule.**
