8 **April 4, 2025 (returning on April 7, 2025), beginning August 4 through August 29, 2025**
9 **(returning on September 2, 2025), and beginning December 17, 2025, through January**
10 **2, 2026 (returning on January 5, 2026); and further suspending portions of Board Rule**
11 **4.2. to effectuate certain dates within the regular meeting schedule to augment the flow**
12 **of business.**

14 WHEREAS, The Board of Supervisors Rules of Order, Section 4.2, states the Board
15 shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at
16 2:00 p.m., unless it is a holiday, in which case the meeting shall be cancelled; and

17 WHEREAS, The Rules of Order Section 4.2.1 also states that during holiday periods,
18 the application of specific days of the week described in the rules shall be revised by the Clerk
19 of the Board as necessary for the efficient conduct of the legislative process or to facilitate the
20 transition of District offices; and

21 WHEREAS, The Rules of Order Section 4.2 further states "the Board shall not meet
22 during the week after Thanksgiving, or between December 24 and December 31"; and

23 WHEREAS, Similar to other sitting legislative bodies in the United States, the Board
24 has established recess periods during the spring, summer, and winter which Members of the
25 Board may plan to be away, without missing any Board or Committee meetings or other

1 important public business, and without causing difficulties in achieving a quorum; now,
2 therefore, be it

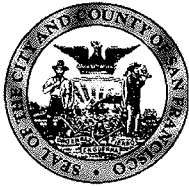
3 MOVED, Pursuant to Board Rules 4.2 and 4.2.1, the following Board meetings are
4 cancelled: January 21 (Martin Luther King Jr. Day); February 18 (President's Day); May 27
5 (Memorial Day); September 23 (Rosh Hashanah); October 14 (Italian American Heritage Day
6 and Indigenous Peoples Day); November 11 (Veterans Day); and November 25, 2025
7 (Thanksgiving); and, be it

8 FURTHER MOVED, To suspend the portion of Board Rule 4.2 that requires the Board
9 to meet during the week of Thanksgiving and prohibits the Board from meeting the week after
10 Thanksgiving, cancelling the meeting of November 25 to observe the Thanksgiving holiday
11 during the week of Thanksgiving, and scheduling the Board to meet on December 2; and, be it

12 FURTHER MOVED, That pursuant to the established tradition of spring, summer, and
13 winter recess periods, the Regular Board and Committee meetings scheduled beginning
14 March 31 through April 4, 2025 (returning on April 7, 2025), beginning August 4 through
15 August 29, 2025 (returning on September 2, 2025), and beginning December 17, 2025,
16 through January 2, 2026 (returning on January 5, 2026), are hereby cancelled; and, be it

17 FURTHER MOVED, To suspend the portion of Board Rule 4.2 which requires the
18 Board to cancel a Tuesday Board meeting after a Monday Holiday as it pertains solely to
19 September 1, to allow the Board to meet on Tuesday, September 2, 2025; and, be it

20 FURTHER MOVED, Pursuant to Board Rule 4.3 the Board is constrained by certain
21 administrative, electoral and legislative deadlines and may schedule Special Meetings when
22 necessary to conduct the City's business.
