3 **Motion responding to the Civil Grand Jury’s request to provide a status update to**
4 **Recommendation No. R1 contained in the 2020-2021 Civil Grand Jury Report, entitled**
5 **“Strategic Alignment: Breaking Through to a Living Wage.”**

7 WHEREAS, The 2020-2021 San Francisco Civil Grand Jury published a report, entitled
8 “Strategic Alignment: Breaking Through to a Living Wage” (“Report”) on June 30, 2021; and

9 WHEREAS, the Board of Supervisors’ Government Audit and Oversight Committee
10 (“GAO”) conducted a public hearing to hear and respond to the Report on
11 September 30, 2021; and the Board of Supervisors adopted Resolution No. 465-21 on
12 October 5, 2021, reflecting the GAO responses to the Report; a copy of which is on file with
13 the Clerk of the Board of Supervisors in File No. 210707; and

14 WHEREAS, Recommendation No. R1 states: “The Board of Supervisors should
15 reinstate the Committee on City Workforce Alignment to Chapter 30 of the Administrative
16 Code and add City College as a member. The reinstatement should be completed no later
17 than February 2022;” and

18 WHEREAS, The Board of Supervisors on October 5, 2021 responded in Resolution
19 No. 465-21 that Recommendation No. R1 “has not been implemented but will be implemented
20 in the future by February 2022; now, therefore, be it

21 MOVED, That the Board of Supervisors reports that Recommendation No. R1 has
22 been partially implemented via Ordinance No. 209-22, which formally re-established the
23 Committee on City Workforce Alignment and includes various appointed seats that would
24 allow for City College representation, a copy of which is on file with the Clerk of the Board of
25 Supervisors in File No. 220879.
