"Strategic Alignment: Breaking Through to a Living Wage" ("Report") on June 30, 2021; and

WHEREAS, the Board of Supervisors' Government Audit and Oversight Committee ("GAO") conducted a public hearing to hear and respond to the Report on September 30, 2021; and the Board of Supervisors adopted Resolution No. 465-21 on October 5, 2021, reflecting the GAO responses to the Report; a copy of which is on file with the Clerk of the Board of Supervisors in File No. 210707; and

WHEREAS, Recommendation No. R1 states: "The Board of Supervisors should reinstate the Committee on City Workforce Alignment to Chapter 30 of the Administrative Code and add City College as a member. The reinstatement should be completed no later than February 2022;" and

WHEREAS, The Board of Supervisors on October 5, 2021 responded in Resolution No. 465-21 that Recommendation No. R1 "has not been implemented but will be implemented in the future by February 2022; now, therefore, be it
