17 in File No. 250735 and is incorporated herein by reference; and

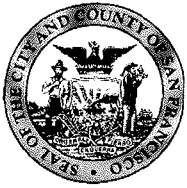
18 WHEREAS, On July 3, 2025, Ali Gilmore, filed a timely appeal to the decision of Public
