18 years professional experience in the State of California as one of the following: certified public
19 accountant or public accountant; licensed real estate broker; attorney; or a property appraiser
20 accredited by a nationally recognized professional organization, certified by the Office of Real
21 Estate Appraisers, or certified by the State Board of Equalization, for the unexpired portion of
22 a three-year term ending September 4, 2028;

24 Susan Elizabeth Miller, seat 4, succeeding herself, term expired, must have a minimum
25 of five years professional experience in the State of California as one of the following: certified

1 public accountant or public accountant; licensed real estate broker; attorney; or a property

3 Office of Real Estate Appraisers, or certified by the State Board of Equalization, for the
4 unexpired portion of a three-year term ending September 4, 2028.
