8 **of San Francisco to waive offset of \$13,891.80 for unpaid services, and Regents of the**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Bradley Bishop v. City and County of
14 San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-544028 by the
15 payment of \$750,000 and waiver of the \$13,891.80 offset for unpaid services. Regents of
16 University of California will also pay \$1,750,000 to the Plaintiff. The lawsuit involves a medical
17 malpractice claim.

18 Section 2. The above-named action was filed in San Francisco Superior Court on
19 February 9, 2015, and the following parties were named in the lawsuit: Plaintiff: Bradley
20 Bishop; Defendants: City and County of San Francisco, Regents of the University of
21 California, N. Young, MD, Rachel MacFarland, RN, Michael Ansfield, MD, Michael Terry, MD,


