3 Ordinance amending the Administrative Code to require that Mayoral and Board of
4 Supervisors appointments to the Reentry Council expire following a member's hiring at
5 designated City departments; increase the number of Reentry Council officers from
6 four to five and require that the fifth officer be a formerly incarcerated member; and
7 increase from 12 to 13 the number of members that constitute a quorum.

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. Chapter 5, Article I of the Administrative Code is hereby amended by
17 revising Section 5.1-3, to read as follows:

18 **SEC. 5.1-3. MEMBERSHIP AND ORGANIZATION.**

19 (a) **Members.** The Council shall consist of 24 members, *as further described below.*

20 (1) ~~Seven of whom~~ *the members* shall be *persons formerly incarcerated former*
21 *inmates* in the San Francisco County Jail, a California Department of Corrections and
22 Rehabilitation adult facility, and/or a United States Bureau of Prisons facility.

23 (2) The Mayor, or the Mayor's designee, shall serve as a member *of the Council,*
24 and *the Mayor* shall also appoint three of these seven members *who are formerly incarcerated*
25 *persons referenced in subsection (a)(1).* Of these three members, at least one must be between

1 the ages of 18 to 35, inclusive, at the time of appointment and have been a person incarcerated
2 an inmate before the age of 24, and at least one shall have expertise in providing services to
3 individuals exiting the criminal justice system.

4 (3) The Board of Supervisors shall designate one of its members to serve as a
5 member of the Council, and shall appoint the other four of the seven members who are
6 formerly incarcerated persons referenced in subsection (a)(1) former inmates. Of these four
7 members, at least one shall have expertise in providing services to individuals exiting the
8 criminal justice system, at least one must have been released from custody within three years
9 of ~~his or her~~ that member's appointment, at least one must have served multiple terms of
10 incarceration, and at least one must self-identify as a survivor of violence or crime.

11 (4) All members of the Council shall be exempt from the Charter requirement
12 that they be electors of the City and County of San Francisco.

13 (5) Mayoral and Board of Supervisors appointments to the Council shall expire 90 days
14 following an appointee's date of hire in any of the following City departments or agencies: the Public
15 Defender's Office, the District Attorney's Office, the Sheriff's Department, the Police Department, the
16 Adult Probation Department, the Juvenile Probation Department, the Office of Economic and
17 Workforce Development, the Human Services Agency, the Department of Children Youth and Families,
18 the Department of Public Health, and the Department of Homelessness and Supportive Housing

19 (6) The following City departments or agencies shall appoint one member each
20 to the Council: the Public Defender's Office, the District Attorney's Office, the Sheriff's
21 Department, the Police Department, the Adult Probation Department, the Juvenile Probation
22 Department, the Department Office of Economic and Workforce Development, the Human
23 Services Agency, the Department of Children Youth and Families, the Department of Public
24 Health, and the Department of Homelessness and Supportive Housing. In addition, Council
25 co-chairs shall invite the San Francisco Superior Court, the Department of Child Support

1 Services, the California Department of Corrections and Rehabilitation Division of Adult Parole
2 Operations, and the United States Probation and Pretrial Services System to appoint one
3 member each to the Council. ~~If any of these four agencies does not appoint a representative, the~~
4 ~~Council co-chairs shall appoint an additional member.~~

5 (7) Members of the Council shall serve two-year terms and shall serve at the
6 pleasure of the appointing authority. Members may serve multiple terms.

7 (b) Quorum. ~~Twelve~~ Thirteen members of the Council shall constitute a quorum, and
8 the Council shall have the authority to act on the vote of the majority of the quorum.

9 (c) Officers. The four members appointed by the Adult Probation Department, the
10 District Attorney's Office, the Public Defender's Office, and the Sheriff's Department,
11 respectively, as well as the Mayor or the Mayor's designee, shall co-chair the Council. In
12 addition, the seven members who are formerly incarcerated persons referenced in subsection (a)(1)
13 shall select by majority vote one of the seven to serve as an additional co-chair of the Council.

17 Section 2. Effective Date. This ordinance shall become effective 30 days after
18 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
19 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
20 of Supervisors overrides the Mayor's veto of the ordinance.

21
22 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
23 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
24 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
25 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

1 additions, and Board amendment deletions in accordance with the "Note" that appears under
2 the official title of the ordinance.
