9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Floridalma Jeronimo, et al. v. City and  
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-591939 by  
13 the payment of \$125,000. The lawsuit involves alleged personal injury and wrongful death  
14 from medical negligence.

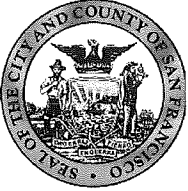
