3 **Ordinance amending the Administrative Code to change the composition of the Family**  
4 **Violence Council and extend the sunset date for the Council to May 1, 2021.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Sections 5.190, 5.190-1, 5.190-2, 5.190-3, 5.190-4, 5.190-5, 5.190-6, and  
14 5.190-7 of the Administrative Code (Chapter 5, Article XIX) are hereby renumbered as  
15 Sections 5.19-1, 5.19-2, 5.19-3, 5.19-4, 5.19-5, 5.19-6, 5.19-7, and 5.19-8, respectively.

16 Section 2. The Administrative Code is hereby amended by revising existing Sections  
17 5.190-4 and 5.190-7 (newly-renumbered Sections 5.19-5 and 5.19-8, respectively), to read as  
18 follows:

20 **SEC. ~~5.190-4~~5.19-5. FAMILY VIOLENCE COUNCIL – COMPOSITION – TERMS OF**  
21 **OFFICE.**

22 (a) **Composition.** The composition of the Council shall broadly represent the ethnic,  
23 racial, gender, age, and sexual orientation diversity of the City and County. The Council shall  
24 consist of the following individuals or their respective designees:

- 25 (1) Presiding Judge of the Superior Court;

- 1 (2) Mayor;
- 2 (3) President of the Board of Supervisors;
- 3 (4) District Attorney;
- 4 (5) Chief of Police;
- 5 (6) Sheriff;
- 6 (7) President of the Commission on the Status of Women;
- 7 (8) Chief of Adult Probation;
- 8 (9) Executive Director of Department of Emergency Management;
- 9 (10) Executive Director of the Domestic Violence Consortium;
- 10 (11) Executive Director of Human Services Agency;
- 11 (12) Executive Director of the Consortium for Elder Abuse Prevention;
- 12 (13) Executive Director of Safe & Sound ~~the San Francisco Child Abuse Council~~;
- 13 (14) Director of the Department of Public Health;
- 14 (15) Executive Director of the Department of Adult and Aging Services;
- 15 (16) Executive Director of the Department of Children, Youth, ~~and~~ & Their
- 16 Families;
- 17 (17) ~~Chair of the Consortium of Batterer's Intervention Programs~~ Medical Examiner;
- 18 (18) Director of the Department of Child Support Services;
- 19 (19) Chief of Juvenile Probation;
- 20 (20) Public Defender;
- 21 (21) Director of the Department of Animal Care and Control;
- 22 (22) Superintendent of San Francisco Unified School District;
- 23 (23) Human Resources Director; ~~and~~
- 24 (24) Chief of the Fire Department; ~~and~~
- 25 (25) Director of the Department of Homelessness and Supportive Housing; and

1                   (26) Executive Director of First 5 San Francisco.

2                   If at any time an agency responsible for designating a member to Seat 1, 10, 12, 13,  
3 ~~17~~, or 22 declines to designate a member and leaves the seat vacant for 60 days or longer,  
4 the Board of Supervisors may appoint a member of the public to fill the seat until such time as  
5 the agency designates a member.

6                   The Steering Committee shall have the authority to appoint up to three members to the  
7 Council. Each such member shall have an interest in family violence prevention and  
8 experience working in academia or the non-profit, medical, or business community. Each of  
9 these members shall serve for a term of one year at the pleasure of the Steering Committee.

10                  (b) **Limitations on Service in Community-Based Organization Seats.** No individual  
11 may serve as a Council member in seat 10, 12, or 13, ~~or 17~~, either as a named member or as  
12 a designee, for more than six years out of any nine-year period. For the purpose of calculating  
13 the number of years of service, any service prior to May 1, 2015, shall not count.

14                   \* \* \* \*

16                  **SEC. ~~5.190-75.19-8~~. FAMILY VIOLENCE COUNCIL – SUNSET.**

17                  Unless the Board of Supervisors by ordinance extends the term of the Family Violence  
18 Council, this Article XIX shall expire by operation of law, and the Committee shall terminate,  
19 on May 1, ~~2021~~2018. After that date, the City Attorney shall cause this Article to be removed  
20 from the Administrative Code.

21  
22                  Section 3. Effective Date. This ordinance shall become effective 30 days after  
23 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
24 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
25 of Supervisors overrides the Mayor's veto of the ordinance.

1 Notwithstanding the Effective Date of this ordinance, it is the intent of the Board that  
2 the Family Violence Council shall continue to operate without interruption in the event the  
3 Effective Date is after May 1, 2018, and that the changes pertaining to membership of the  
4 Council contained in this ordinance shall occur on the Effective Date.

5  
6 Section 4. Scope of Ordinance. Except as stated in Section 1, in enacting this  
7 ordinance, the Board of Supervisors intends to amend only those words, phrases,  
8 paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or  
9 any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as  
10 additions, deletions, Board amendment additions, and Board amendment deletions in  
11 accordance with the "Note" that appears under the official title of the ordinance.




