12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Administrative Code is hereby amended by adding Section 10.100-24,
14 to read as follows:

15 **SEC. 10.100-24. ANIMAL SHELTER FUND.**

16 (a) **Establishment of Fund.** The Animal Shelter Fund is established as a category eight
17 fund for the purpose of receiving donations of money, property, and personal services to the City and
18 County of San Francisco through the Animal Care and Control Department for the construction and
19 use of the new animal shelter at 1419 Bryant Street, including without limitation, the receipt of funds to
20 pay for furniture and equipment for the new animal shelter.

21 (b) **Use of Fund.** The money, property, and personal services in this fund shall be expended
22 or used solely for the purposes of construction, reconstruction, restoring, repairing, or improving the
23 grounds, buildings and/or facilities of the new animal shelter, including furnishing and equipping the
24 new animal shelter.


1 (c) Gift Acceptance Authority. The Director of the Animal Care and Control Department
2 shall have the authority to accept and expend any donation of money, property, or personal services in
3 accordance with this Section 10.100-24 without further action by the Board of Supervisors.

4 (d) Administration of the Fund. The fund shall be administered by the Animal Care and
5 Control Department.

6 (e) Reporting Requirement. The Animal Care and Control Department shall submit an
7 annual written report to the Board of Supervisors and the Controller showing all donations received,
8 the nature and amount of such donations, and a description of the individual expenditures from the
9 Fund. The report shall be submitted within the first two weeks of July and shall cover the prior fiscal
10 year.

11
12 Section 2. Effective Date. This ordinance shall become effective 30 days after
13 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
14 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
15 of Supervisors overrides the Mayor's veto of the ordinance.
