14 Section 1. The Board of Supervisors hereby adopts and implements the First
15 Amendment to the 2019-2022 Memorandum of Understanding (“MOU”) between the City and
16 County of San Francisco and the Supervising Probation Officers, to include a firearms
17 instructor premium and provide a one-time payment to employees eligible for the premium.
