3 **Ordinance amending the Planning Code to extend the Lower Polk Street Alcohol**
4 **Restricted Use District to June 1, 2023; to expand the circumstances in that District**
5 **when temporary closures of liquor establishments are not considered abandonment of**
6 **such uses, and provide that such temporary closures in that District are not considered**
7 **an enlargement, alteration, intensification, abandonment, or change of use, provided**
8 **that any demolition permits required for the repair, renovation, or remodeling work**
9 **have been approved submitted by January 1, 2018; affirming the Planning**
10 **Department's determination under the California Environmental Quality Act; and**
11 **making findings of public necessity, convenience, and welfare under Planning Code,**
12 **Section 302, and findings of consistency with the General Plan, and the eight priority**
13 **policies of Planning Code, Section 101.1.**

21 Be it ordained by the People of the City and County of San Francisco:

22 Section 1. Environmental and Land Use Findings.

23 (a) The Planning Department has determined that the actions contemplated in this
24 ordinance comply with the California Environmental Quality Act (California Public Resources
25 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of

1 Supervisors in File No. 180190 and is incorporated herein by reference. The Board affirms
2 this determination.

3 (b) On March 29, 2018, the Planning Commission, in Resolution No. 20147,
4 adopted findings that the actions contemplated in this ordinance are consistent, on balance,
5 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The
6 Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of
7 the Board of Supervisors in File No. 180190, and is incorporated herein by reference.

8 (c) On March 29, 2018, the Planning Commission, in Resolution No. 20147,
9 approved this ordinance, recommended it for adoption by the Board of Supervisors, and
10 adopted findings that it will serve the public necessity, convenience, and welfare. Pursuant to
11 Planning Code Section 302, the Board adopts these findings as its own. A copy of said
12 Resolution is on file with the Clerk of the Board of Supervisors in File No. 180190, and is
13 incorporated herein by reference.

14
15 Section 2. The Planning Code is hereby amended by revising Section 788, to read as
16 follows:

17 **SEC. 788. LOWER POLK STREET ALCOHOL RESTRICTED USE DISTRICT.**

18 * * * *

19 (d) **Controls.**

20 * * * *

21 (2) Whenever a liquor establishment has discontinued its use for a continuous
22 period of one year or more, the liquor establishment shall be deemed to have abandoned its
23 use as a liquor establishment; provided that a break in continuous operation shall not be
24 interpreted to include the following, as long as the location of the establishment does not
25 change, the square footage used for the sale of alcoholic beverages does not increase, and

1 the type of California Department of Alcoholic Beverage Control Liquor License ("ABC
2 License") does not change:

3 (A) Re-establishment, restoration, or repair of an existing liquor
4 establishment on the same lot after total or partial destruction or damage due to fire, riot,
5 insurrection, toxic accident, or other force majeure; or

6 (B) Temporary closure of an existing liquor establishment for repair,
7 renovation, or remodeling, *including full demolition of an existing building and new construction,*
8 *and including voluntary repairs, renovations, or remodeling,* provided that permit applications for
9 the repair, renovation, or remodeling or demolition work shall be submitted to the City upon or
10 prior to the temporary closure and such permits and work shall be pursued diligently to
11 completion; or

12 (C) A change in ownership of a liquor establishment or an owner-to-
13 owner transfer of an ABC License.

14 * * * *

15 (e) **Sunset *Provision*Date.** This Section 788 shall *expire by operation of law on June 1,*
16 *2023, be repealed five (5) years after its initial Effective Date* unless the Board of Supervisors, on
17 or before that date, extends or re-enacts it. *Following its expiration, the City Attorney shall cause*
18 *this Section to be removed from the Municipal Code.*

20 Section 3. The Planning Code is hereby amended by revising Section 723, to read as
21 follows:

22 **SEC. 723. POLK STREET NEIGHBORHOOD COMMERCIAL DISTRICT.**

(1) *{Note deleted.} Temporary closures of existing liquor establishments located within the Lower Polk Alcohol Restricted Use District for repair, renovation, or remodeling that meet the requirements of Section 788(d)(2)(B) shall not be considered enlargement, alteration, intensification, abandonment, or a change of use of a conditional use permit pursuant to Section 178 of this Code, provided that any demolition permits required for the repair, renovation, or remodeling work have been approved submitted by January 1, 2018.*


Section 4. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the

1 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
2 of Supervisors overrides the Mayor's veto of the ordinance.

3
4 Section 5. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
5 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
6 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
7 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
8 additions, and Board amendment deletions in accordance with the "Note" that appears under
9 the official title of the ordinance.


