20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the MOU.

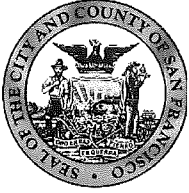
