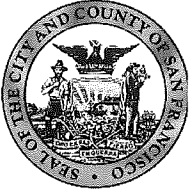
13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the Collective
15 Bargaining Agreement (“CBA”) between the City and County of San Francisco and the San
16 Francisco District Attorney Investigators’ Association, to be effective July 1, 2022 through
17 June 30, 2024.

18 The CBA so implemented is on file with the Clerk of the Board of Supervisors in Board
19 File No. 220570.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the CBA.

22 Section 3. Effective Date. This ordinance shall become effective upon enactment.
