15 Section 1. The Board of Supervisors hereby adopts and implements the decision and
16 award of the Arbitration Board under Charter Section A8.490-4, establishing the Memorandum
17 of Understanding ("MOU") between the City and County of San Francisco and the Service
18 Employees International Union, Local 1021, to be effective July 1, 2019 through
19 June 30, 2022.


20 The Arbitration Board decision and award and the MOU so implemented are on file
21 with the Clerk of the Board of Supervisors in Board File No. 190531.

22 Section 2. The Board of Supervisors hereby authorizes the Department of Human
23 Resources to make non-substantive ministerial or administrative corrections to the MOU.

2 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
3 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
