13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the Collective  
15 Bargaining Agreement ("CBA") between the City and County of San Francisco and the San  
16 Francisco Deputy Sheriffs' Association, to be effective July 1, 2024 through June 30, 2027.

17 The CBA so implemented is on file with the Clerk of the Board of Supervisors in Board  
18 File No. 240519.

19 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
20 Resources to make non-substantive ministerial or administrative corrections to the CBA.

21  
22 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
23 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance  
24 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of  
25 Supervisors overrides the Mayor's veto of the ordinance.
