Article 13 of the Park Code is hereby amended by revising Section 13.01, to read as follows: SEC. 13.01. CITIZENS' ADVISORY COMMITTEE. (a) Membership. Effective September 1, 2023, the *There is hereby established a* Park, Recreation and Open Space Advisory Committee ("Committee") shall be comprised of <u>13</u>12*twenty-three* members. *ElevenTwenty-two* members shall be appointed by the members of the Board of Supervisors and approved by the full Board, with one member appointed by each Supervisor from their his or her supervisorial district; and each Supervisor shall also appoint from their supervisorial district a specific alternate for the regular voting member, subject to approval by the full Board. The alternates shall not be seated on the Committee, but if a regular voting member is

1 unavailable to attend then that regular voting member's specific alternate shall be seated and shall act 2 in the place of the regular voting member. Alternates are encouraged to attend and participate in 3 meetings of the Committee. The Mayor shall appoint one member of the Committee, who shall be a City resident. The President of the Board of Supervisors shall appoint one additional 4 5 member of the Committee who represents an environmental justice organization based in San 6 Francisco, subject to approval by the Board of Supervisors. The Committee members shall all be 7 <u>City residents and shall have relevant experience with and one member appointed by each</u> Supervisor from a list, maintained by the Recreation and Park Commission ("Commission") of 8 9 individuals nominated by organizations having as a primary focus park, environmental, 10 recreational, cultural, sports, youth, disability, racial equity, or senior citizen issues. Four of the 11 members chosen from the list maintained by the Commission shall be individuals nominated by an 12 environmental organization. If the system of district elections set forth in Charter Section 13.110 is 13 discontinued, each Supervisor shall appoint one member of the Committee from the list maintained by 14 the Commission and one member without restriction. One member of the Committee shall be appointed 15 by the Mayor.

(b) Terms. The Committee members shall serve <u>at the pleasure of their appointing</u> <u>authority</u> for terms of two years, <u>at the will of the appointing authority</u>, <u>except that at the first</u> <u>meeting of the Committee the General Manager of the Recreation and Park Department</u>
("Department") shall, by lot, designate twelve members to serve terms of one year. Thereafter, all members shall be appointed to two-year terms and no member shall serve more than four consecutive terms.

(c) **Transition Period.** <u>Prior to September 1, 2023, the Committee shall adopt a transition</u> <u>roster that identifies which of the current Board-appointed members shall serve as regular voting</u> <u>members versus as alternates.</u> <u>Where there are already two members appointed by the same</u> <u>Supervisor, those members shall attempt to reach agreement as to which of them shall be the regular</u>

1	voting member and which of them shall be the alternate, before September 1, 2023, subject to approval
2	of the Committee; but if they do not agree, then the Committee may designate their assignments by lot.
3	The Committee's adoption of a transition roster shall not impact the authority of the Mayor or Board of
4	Supervisors to fill vacancies or reassign which members serve as regular voting members and
5	alternates. The term of the Presidential appointee shall begin on September 1, 2023. From the
6	effective date of Proposition C, which appeared on the March 7, 2000 ballot and until January 31,
7	2001, the Open Space Advisory Committee created by former Charter Section 16.107 shall serve as the
8	Committee created in section (a) above. During this transition period the Open Space Advisory
9	Committee shall take all steps necessary to ensure a smooth transition to the new Committee. The
10	Mayor and the members of the Board of Supervisors may fill vacancies on the Committee that occur
11	during this transition period according to the requirements of former Administrative Code Section
12	590(a). By July 1, 2000, the Commission shall prepare, and the Board of Supervisors shall approve or
13	modify, a list of organizations qualified to nominate individuals for Committee membership. Changes to
14	the list shall be made by the Commission and approved or modified by the Board of Supervisors
15	annually. The Board of Supervisors and the Mayor shall make their first appointments to the
16	Committee by February 1, 2001.
17	(d) <b>Duties.</b> The Committee shall have the following duties:

19	(5) The Committee shall hold meetings at least once a month <u>in City Hall</u> and shall
20	adopt its own rules of procedure.

Section  $\underline{23}$ . Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the

ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section <u>3</u>4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.
