25 Section 1. The Board of Supervisors hereby adopts and implements the decision and

16 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
17 Resources to make non-substantive ministerial or administrative corrections to the MOU.

18  
19 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
20 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance  
21 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of  
22 Supervisors overrides the Mayor’s veto of the ordinance.


