13 and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-  
14 551699 by the payment of \$60,000. The lawsuit involves alleged personal injury from a  
15 motorcycle collision with a San Francisco Police Department patrol car.

16 Section 2. The above-named action was filed in San Francisco Superior Court on April  
17 27, 2016, and the following parties were named in the lawsuit: plaintiffs: Jason Douglas and  
18 Carol Grindley; defendant: City and County of San Francisco.




