14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum
16 of Understanding (“MOU”) between the City and County of San Francisco and the Service
17 Employees International Union, Local 1021: Staff & Per Diem Nurses, to be effective July 1,
18 2022 through June 30, 2024.

19 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board
20 File No. 220696.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.
24 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance
