14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The Board of Supervisors hereby adopts and implements the decision and  
16 award of the Arbitration Board under Charter Section A8.590-5, establishing the Memorandum  
17 of Understanding ("MOU") between the City and County of San Francisco and the San  
18 Francisco Deputy Sheriffs' Association, to be effective July 1, 2019 through June 30, 2022.

19 The Arbitration Board decision and award and the MOU so implemented are on file  
20 with the Clerk of the Board of Supervisors in Board File No. 190543.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

24 Section 3. This ordinance shall become effective upon enactment. Enactment occurs  
25 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
